## NOTABLE WORK

### Hallam Bluff Residence | Aspen, CO

Set prominently in downtown Aspen, Colorado, this 4-acre residential project nestles into an existing mature conifer grove overlooking the Hallam Lake Nature Preserve, with distant views of Aspen's ski slopes and surrounding mountain peaks. The design team took great care in acknowledging the property's rich historical ties to the prominent Paepcke family and former location of the Given Institute. The project's objective is to comprehensively understand and deeply respect the larger-scale environmental factors. Prior to embarking on the design process, significant effort was dedicated to thorough site analysis. This meticulous approach ensures a comprehensive understanding of the site's unique characteristics and allows for the development of a design that harmonizes with and respects the surrounding environment. From the beginning, the highest emphasis was placed on preservation of the existing mature trees and this intention was successfully carried through nearly eight years, design to completion.

### West Meadows Residence | Telluride, CO

*CCASLA Honor Award for Design, 2022*

This property in the West Meadows Neighborhood of Telluride is set amidst rolling terrain with nearly 360 views of the regions most iconic peaks and ski resorts. DHM Design was pleased to work with the site owner's representative and contractor for site planning efforts related to positioning a pond with a very specific surface area and storage volume within the tight site constraints. The goal was to achieve pond development while not impacting the (undeveloped) building envelope for a future residence. This effort was successfully completed, which in the end also helped to protect the water rights of the site owner. The project included garden design around the main house, trails throughout the property, significant tree planting, and measures such as restoration seeding to enhance and protect the natural resources on site. Many iconic western landscapes and properties maintain integrity and resource significance due to careful planning, and implementation of these strategies.

### Aspen Valley Ranch | Pitkin County, CO

DHM Design is creating a master plan for the Aspen Valley Ranch, located in Pitkin County, Colorado. The 800+ acre ranch borders the White River National Forest and has been a working ranch since the 1800's. That tradition will continue with the restoration of the historic barn, new agricultural buildings, residential buildings, pasture restoration, the design and installation of a new irrigation system, and extensive habitat improvements.
