## MOST NOTABLE WORK

### Sun Valley Community Park/ Weir Gulch & South Platte River Confluence

DHM Design in partnership with ICON Engineering developed a master plan for park and drainage improvements that looked at improving river access and creating a community amenity for the City of Denver at the confluence of Weir Gulch & the South Platte River. Upon approval of a master plan concept, the design team will continue to develop designs for bidding purposes in seeing the vision for the corridor fully implemented. The master plan improved river access, developed water quality solutions, created a safe environment, promotes outdoor recreation, and developed social gathering areas. The park is to become a restored natural open space park that utilizes low water landscapes and natural materials that engages the community and educates them about the natural world around us. The project is one of 5 major projects along the Platte River identified by the City of Denver and The Greenway Foundation as part of the River Revitalization Improvement Plan.

### Sand Creek Trail

#### 2001 CCASLA Merit Award and Land Stewardship Designation

Mark assisted with master plan development that looked at trail alignment alternatives, right-of-way and easement acquisition, implementation strategies. This work continued with the development of the master plan into conceptual designs and construction documents. The Sand Creek Trail corridor is over 6 miles in length.
