Aspen Valley Ranch | Aspen, CO

Aspen Valley ranch is a sprawling private ranch in the heart of the Roaring Fork Valley. Allie has been an integral part of the team creating a master plan for the ranch which includes designing world-class residential landscapes, restoration of historic architectural and landscape features, pasture restoration, weed management, extensive habitat improvements and ranch wide infrastructure including irrigation, fertigation and circulation.

Delta County Trails Recreation Master Plan | Delta County, CO

Allie was part of the DHM Design team that Delta County selected for a county wide comprehensive Recreation and Trails Master Plan. The Master Plan acts as the guiding document for the development of future trail infrastructure and was based on extensive community input, outreach and feed back. The plan helps to prioritize the goals of the county and guide future efforts for funding and land acquisition. Programmatic elements included in the master plan are new and existing trails, opportunities for trail connections, recreation facilities and associated infrastructure that work with Delta county's heritage as agricultural hub of Colorado and an expanding population center on Colorado's Western Slope. The Master Plan was recently approved by the Delta County Board of County Commissioners and lays the groundwork for a community driven plan for success.

Navajo Nation IRMP | Navajo, UT

DHM is currently working with the Navajo Division of Natural Resources on an Integrated Resource Management Plan (IRMP) for the Nation's forestlands. A major goal of the IRMP is to increase interdisciplinary coordination within the Navajo Division of Natural Resources; DHM worked to create a user friendly document which aids in increasing intradepartmental efficiency and communication, reduced duplication and contradictory efforts, greater transparency and accountability, collaborative funding and resource sharing, increased and coherent communication and outreach tools for tribal members and regional partners, and clear division wide priorities, goals and vision.
