## NOTABLE WORK

### Northglenn Northwest Open Space | Northglenn, CO

The Northglenn Northwest Open Space is a prime example of how communities look to increase capacity of spaces, use community involvement, and mitigate problems like drainage, which is all a part of what DHM Design does best. NWOS includes approximately 40 acres of land dedicated to athletic fields. This project will include the implementation of designs for shade/weather protection structures, permanent restroom and concession facilities, field configuration, expanded parking and trails throughout the complex. Design completion for this project is set for the current year and construction completion is based on funding that Northglenn is actively seeking.

### Harvie Open Space | Parker, CO

In early January 2017, the Board of Douglas County Commissioners conveyed a 72-acre property known as Ray J. Harvie Park to the Town of Parker. The property, located just north of Mainstreet and Canterbury Parkway, will be maintained by Parker and used for open space and passive recreation. The property holds a conservation easement allowing for minimal improvements that is designed to protect the long-term open space values of the site. DHM Design was pleased to be tasked with site improvements keeping conservation easement in mind. These added amenities include soft-surface trails, interpretive signage, gravel parking lot with up to 20 spaces, picnic shelters, tables, benches, one restroom facility, wood/smooth wire fencing, plus a maximum of two historic structures. Based upon input received from residents regarding improvements, DHM will also include modifications of relocating several soft-surface trails and trailside seating. Completion of this renovation project will add significant passive recreation to the total 912-acres of open space Parker currently holds.

### Arvada Holistic Health and Fitness Park | Arvada, CO

DHM is currently working with the City of Arvada and Red Rocks Community College Arvada campus to bring not only a new park to the community, but a new approach to healthy living. This unique park will focus on physical, mental, emotional, and spiritual aspects of wellness with hopes of features such as; a "challenge zone" with fitness equipment, a "therapy zone" with reflexology path, a "vitality zone" with pavilion for yoga and other mind-body activities, along with landscaping and sensory art for all the senses. This 9-acre site shared with the campus and Arvada Utilities stretches along the north side of Miller Street and west side of Kipling Parkway. As the city works to complete funding for this project, DHM is keeping the public up to date on each phase of the process while working on concept and schematic designs which will also focus on educational opportunities for the students.
